MINUTE 1035.2014. WELCOME.

The Chairman extended a warm welcome and best wishes to all Councillors to the first meeting of the New Year with special wishes to Cllr Joan Kirkham who continues to recover from her recent illness.

MINUTE 1036.2014. DECLARATION OF INTEREST.

With the exception of the Chairman who declared an interest on all planning issues, no member declared an interest in any other listed item on the Agenda.

MINUTE 1037.2014. AONB PRESENTATION.

Ms Lowri Hughes, the AONB Community Warden gave an interesting presentation of volunteer work programme the Isle of Anglesey AONB undertakes that includes a variety of conservational work. Members were given the opportunity to ask relevant questions and the Chairman thanked Lowri for a very informative and interesting presentation.

MINUTE 1038.2014. COUNTY COUNCILLORS REPORT ON LOCAL MATTERS.

County Cllr Alwyn Rowlands briefed members of a special meeting to be held at Beaumaris Primary School on the 30th January 2014 at 5:30pm in order to raise awareness and opportunities to review services currently provided and carried out by the County Council. The meeting was for voluntary bodies within the Community to assist due to projected cut backs and members were urged to attend to raise any issues pertinent to the Seiriol Ward.

County Cllr Carwyn Jones briefly stated that following a survey for a Dog Bin to be located at Llansadwrn Playfield – the request could not be justified.

MINUTE 1040.2014. MATTERS ARISING FROM THE MINUTES.
