**1653.1 The Chair, Cllr Idris Alan Jones, welcomed everyone to the

1655. VACANT SEAT.

**1655.1 The Clerk confirmed that no-one had responded to the official
notice prior to the closing date and therefore there would be no
election for the appointment of a new Community Councillor.**

1656.1 It was reported that the June 2018 (13th) minutes were correct. (JK / JG).

1657. MATTERS ARISING FROM THE MINUTES.

1657.1 Seiriol Extra Care Housing - No further report.

1657.2 Seiriol Area Schools Modernization Report - Consultation ended 2/7/2018. It has been decided that Beaumaris School will close and that the Llangoed & Llandegfan Schools will need investment and repairs.

1657.3 Flashing Speed Signs near the Playground, Llansadwrn - a further grant application for the purchase of the sign has been successful and expect to install as soon as possible.

1657.4 New Projector to the Hall - it was disappointed to note that there were no developments and the Clerk stated that he would make an effort to resolve the situation as soon as possible.

1657.5 Lights above the Snooker Board - report that the issue is complete.

1657.6 The British Gas Bill - a report by the Clerk that the £8,500 Bill has now been paid in full.

1657.7 Playing Field Grass Cutting - it was noted that there was a need to further cut the grass at both Playing Fields and that the Clerk would arrange to contact Mr Dafydd Hughes.

1658. FINANCE MATTERS.

1658.1 The Clerk gave a full report of the Payments & Receipts of both the Council and Hall Accounts for the months of June, July & August 2018 together with a Bank Reconciliation report and this was duly received and accepted by the members.

1659 PARISH HALL MATTERS.

1659.1 Flat Roofing - urgently need to resolve and complete the work.

1659.2 Fire Door & Men's Toilets - it was noted that both needed attention and to arrange a site inspection in order to proceed with a planning application if the work needs to be earmarked for next year. Estimates for the work would also need to be prepared for possible grant assistance and to assist with setting the precept for 2019/2020.

1659.3 External Painting - need to include at doing the work next year and to receive an estimate for precept purposes.

1659.4 Caretaker's Role & Cleaning the Hall - it was noted that the Chairman & Cllr Nia Foulkes had met with Wena and both had reviewed her terms and salary. Members accepted the review unanimously and it was noted that the floor of the Hall had already been addressed

1659.5 Sound System - the Chair said that there was a need to consider buying a new microphone to improve the sound in the Hall and that he will arrange prices with Mr Maldwyn Williams and ask the organizers of the Fun Race for any contribution.

1659.6 Weed Killing - need to arrange for this work to be done.

1660.1 There was a long discussion about the uncertainty of how many Stones that were located in the Llandegfan Church Cemetery. It was believed that there are 7 in existence and that the land around the graves is unstable. The Clerk had received an estimate of £ 1,140 + VAT for the treatment of 3 of the Graves and that the Community Council had no statutory responsibility to undertake the work although the Church was happy for the Council to undergo any repairs. After careful consideration, members felt uncomortable not to spend any public money and not to proceed with the scheme because it could lead to a dangerous precedent.
