1848. WELCOME.

1848.1 The Chair, Councillor Idris Alan Jones, welcomed everyone to the meeting.

1848.2 He was concerned about the outbreak of the coronavirus news and the huge impact and implications on all our daily lives in the months to come. The Clerk, will no doubt, inform us all of developments when they occur, but the most important message will be the well-being of all individuals, not only within our own community but across the country as a whole.

1849. DECLARATION OF PERSONAL/PREJUDICIAL INTEREST.

1849.1 Councillor Mr Alun Roberts declared a personal interest in the Ynys y Big planning application (minute 1855.2) as he had met and discussed the application with the site's neighbours. The personal interest was not prejudicial and so he remained in the room to listen to other members ' comments and took no part in any discussion/decision.

1849.2 Councillor Mr Eurfryn Davies declared a personal interest as prejudicial to minute item 1853.3 as he was Chairman of the football club and he left the meeting when the item was being discussed.

1850. POLICE REPORT – PCSO DAVE WEBSTER.

1850.1 The Chairman welcomed PCSO Dave Webster to the meeting to provide members with an update since the open public meeting held last October. PCSO Webster reported that there had been no further incidents, however, there had been minor domestic issues to resolve. He reported on the current Coronavirus COVID19 situation and hopefully the Government will amend legislation to allow Police Officers more power to arrest any public offences in breach of the set guidance. He also informed the meeting that PCSO figures on Anglesey were now down to 11 for the whole of the Island, therefore, resources were stretched. Finally, 66 new Police Officers had been recruited in North Wales with the majority stationed in the North Eastern area of the region. The Chair thanked PCSO Webster for his detailed report and hope to see him again in the next 6 months.

1851. CONFIRMATION OF MINUTES OF MEETINGS

1851.1 **Full Council Meeting – 12 February 2020** – the minutes were confirmed and signed as being true and correct (GG/NF).

1852. MATTERS ARISING FROM PREVIOUS MEETINGS.

1852.1 **Llansadwrn Flood Alleviation Scheme** - the clerk said that he had visited the site and that the condition of the field was severe. It was agreed that a letter would be sent to the County Council’s Property Department to complain about the situation and that attention was needed as soon as possible in the interests of health and safety and that the playing field will have to remain closed for the foreseeable future.

1852.2 **Tree Planting (Llansadwrn Playground)** – The clerk had received a letter from St. Llansadwrn requesting tree/tree planting in the playing field to mark the hundred years since the church in Wales disembarked and church England and that all of the churches at Bro Tysilio were running activities in July – the day of Llansadwrn will be Thursday (16/7/2020) – one suggestion was to plant a tree/tree and involve the children of the village in the activity – members were agreed unanimously.

- 1852.3 **Lon Fain** – it was noted that some of the lights were not working – Councillor Alun Roberts to contact the Footpath Department.
- 1852.4 **New Chairs for the Parish Hall** – decision received from the Y Gymdeithas’ Ynys Mon Fund which had approved our grant application up to £2,498.00. The Chair thanked the Clerk for his work in this matter.
- 1852.5 **New Notice Board** – The Clerk informed the meeting that he will write to the County Council to obtain consent and that the site adjacent to the Old Post junction was admissible.
- 1852.6 **Bus Shelter Seating** – The clerk said that this work is due to commence during April.
- 1852.7 **BT Llansadwrn Kiosk** – The clerk advised that the BT company will commence the decommissioning work within the next month and will inform the clerk when the work has been completed.
- 1852.8 **War Memorial Cleaning** – the clerk had received an e-mail from GT Problast Limited Company in Colwyn Bay which had provided an estimate of £250.00 + VAT to undertake the necessary work. The company would use special stone-cleaning equipment recognised by CADW and the English Heritage for restoration and conservation of such structures as war memorials. Members unanimously approved the quotation. The clerk to liaise with the company with a view to completing the work before the end of April 2020.
- 1852.9 **Second World War celebrations (VE Day)** – a short report by Councillor Nia Foulkes was given that arrangements for the service and short activity in the Parish Hall on Friday morning 8/5/2020 to start at 10:00am were in hand. The Chair thanked her for undertaking the responsibility.
