**MINUTE 1210.2015. WELCOME & DECLARATION OF INTEREST.**

1210.1 The Chairman extended a warm welcome to all the Councillors.

1210.2 Cllr John Griffith declared a prejudicial interest in all Planning Applications.

**MINUTE 1211.2015. TO ACCEPT & APPROVE THE MINUTES OF THE PREVIOUS  
MONTHLY MEETING.**

1211.1 The minutes of the previous meeting (11<sup>th</sup> March 2015) were signed and approved as a true record. **ET/LAJ.**

**MINUTE 1212.2015. MATTERS ARISING FROM THE MINUTES.**

1212.1 The Clerk confirmed that the County Councils' Waste Management Department had replied to the concerns of our Council and were preparing to visit the mentioned sites outlined in our complaint regarding the state of dog excrement (see minute 1200.1).

1212.2 The Clerk confirmed that a letter had been sent to the County Councils' Planning Department (Dangerous Structures Section) and they had arranged to conduct a site visit to ascertain the position before responding and taking the next steps (see minute 1200.2).

1212.3 The Clerk confirmed that he still awaits a response to the possibility of extending the pavement outside Maldwyn House before reporting back to the Council (see minute 1200.3).

1212.4 It was noted that the overgrown hedge outside Mill Bank Cottage (see minute 1192.5) had not been cut and following information to hand, it was resolved to request that the County Council sends an enforcement letter to the landowner.

1212.5 The Clerk confirmed that a letter had been sent to the County Councils' Highways Department to bring their attention to complaints regarding the deteriorating road surface from the Maldwyn Junction to the Church in Llandegfan and he was hoping to receive a reply in order to report back to the next meeting (see minute 1205.1).
