## **MINUTE 1222.2015. MATTERS ARISING FROM THE MINUTES.**

- 1222.1 **Retaining Wall opposite Maldwyn Stores** – confirmation that a letter had been received from the County Councils' Planning Department (Dangerous Structures Section) in response to the Community Councils' concerns and due to the height of the wall, it was the landowners responsibility to ensure its maintenance.
