MINUTE 1397.2016. WELCOME & DECLARATION OF INTEREST.

1397.1 The Chairman extended a warm welcome to all the Councillors.

1397.2. **Declaration of Prejudicial Interest – NONE.**

MINUTE 1398.2016. TO ACCEPT & APPROVE MINUTES OF THE PREVIOUS MONTHLY MEETING.

1398.1 The minutes of the previous meeting (7th September 2016) were duly accepted and signed as being a true record. **(TC/IAJ).**

MINUTE 1399.2016. MATTERS ARISING FROM THE MINUTES.

Cllr Mairede Thomas gave a verbal account following three meetings she had recently attended:

1399.1 **Joint Local Development Plan Sessions – Anglesey & Gwynedd – Examination Period:**

Cllr Thomas stated that the sessions had been interesting and the following points had been made:

- a. Community Housing – will they be sustainable;
- b. The Impact on the Welsh Language;
- c. Improved Measures now currently within the documents and;
- d. The New Wylfa and on how to address the Welsh Language Policy.

1399.2 **Meeting held on the 14th September 2016:**

Cllr Thomas stated that she had prepared a factual document on behalf of the Council accompanied with photographic evidence and was told by the Inspectorate that he could not allow this further submission as there were too many errors. She also mentioned that the Local Plan had failed to mention the AONB and the new GeoParc and was pleased to hear that her comments would be taken on board and that it would be included in the Development Plan.

1399.3 **Renewable Energy** – it was confirmed that calls for a public consultation on any proposed solar parks would be part of any planning application. Cllr Thomas also mentioned Noise From the Wind Turbines and mentioned that methodology was now in place to measure the noise and that it would be up to the Assembly Government to decide on what level to be implemented

Cllr Mairede Thomas was thanked by the Chairman for her report and all the hard work she had put in on behalf of the Community Council in these matters.

1399.4 **Planning Application – Ger y Nant, Llandegfan (17C226G)** – Cllr Idris Alan Jones expressed his disappointment that this application had been REFUSED by the Planning Committee and made a request to the Clerk that he writes to the County Council for an explanation and report back to the next meeting.

1399.5 **National Grid Consultation** – following on from recent meetings Cllr Mairede Thomas duly informed members that it appears the only grounds to refuse the pylons would be for landscaping reasons.

MINUTE 1400.2016. PLAYFIELD MATTERS.

1400.1 **Keep Wales Tidy Scheme** – expected works at Llansadwrn Play Field had been done, however, it was pointed out that additional clearing of the site is needed.

1400.2 **New Bench at Llansadwrn** – it was agreed to proceed and purchase a new bench with Glasdon at a cost of around £500.00

MINUTE 1402.2016. HIGHWAY MATTERS.

1402.1 **New Bench on Lon Allt Bryn Mel** – following on from the last meeting, members also approved to purchase an additional seat at this site for a similar price to that as per (minute 1400.2) above.

1402.2 **Eglwys St Tegfan's Site** – it was duly noted that a meeting had been arranged for 1:00pm on the 13th October 2016 with the County Council to discuss and resolve the ongoing flooding during heavy rain.

1402.3 **Situation at B5109 Allt Goch, Beaumaris** – it was duly noted that resurfacing works had started mid September and that there had been a need to close the road in order to complete the works as quickly as possible and prevent further inconvenience.

1402.4 **Calming Traffic Measures** – it was duly noted that the County Council would carefully consider after a full survey as to whether to reinstate speeding ramps at certain locations following resurfacing works due to additional costs now being imposed.

1402.5 It was noted that County Cllr Carwyn Jones had brought the County Council's attention to the overgrowth at 41 Gwel Eryri, Llandegfan.
