He explained that a grant application bid for £10k had been successful and requested members to consider factors surrounding the wildlife status connected with the Local Nature Reserve at Cytir and urged the Council to re-engage and forge a link with the site in order to improve our lifestyle as part of the 'Create your Space' programme. Members in attendance agreed unanimously to send a letter of support to the project and to resurrect the partnership and work closely with Menter Môn .
