MINUTE 1603.2018. WELCOME AND DECLARATION OF INTEREST.

1603.1 Cllr Idris Alan Jones (Chair) welcomed everyone to the meeting.

1603.2 **Declaration of Personal and/or Prejudicial Interest.**

1603.2.1 Cllr John Wyn Griffith declared a prejudicial interest in the planning application(s) listed as he was a member of the County Council's Planning Committee.

1603.2.2 Cllr Alun Roberts declared a personal interest as a member of the Beaumaris School Governors in the item surrounding the County Council's Education Reorganization in the Seiriol Ward but as the prejudice was not of a personal nature, he took part in the item.

1603.2.3 Cllr Alun Roberts also declared a personal interest as a County Councillor in the planning application of Cae Ffynnon, Lon yr Eglwys, Llandegfan (17C73G) but as the prejudice, again, was not of a personal nature, he took part in the item.

1603.2.4 County Councillor Carwyn Jones County Councilor declared a prejudicial personal interest in the County Council's Education Reorganization in the Seiriol Ward but had received special dispensation from the Standards Committee on 18/7/2017 to take part in the item .

MINUTE 1604.2018. TO ACCEPT MINUTES OF FEBRUARY 2018.

1604.1 The minutes of the February 2018 monthly meeting (14th) were duly accepted and signed as being a true record. **(AR/NF).**

MINUTE 1605.2018. MATTERS ARISING FROM THE MINUTES.

1605.1 **Seiriol Extra Care Housing** - It was reported that the County Council's Executive Committee had made a final decision on the 19th February 2018 of locating the site near the present site of the Beaumaris Primary School. It was also noted that this decision had not pleased everyone and it was resolved to keep this item on the program of future meetings in order to keep up to date with any further information or development.

1605.2 **Seiriol Area School Modernization Report** - both County Councillors Alun Roberts and Carwyn Jones reported that the County Council's Executive Committee had made a decision to extend the date of the Consultation period following but would now need to consider the option of whether to close Beaumaris Primary School or Llangoed Primary School. Again, this decision had not been met with total satisfaction. It was also resolved to leave this important item on the agenda for future meetings for the receipt of any further information or development.

1605.3 **Local Development Plan (Not Included in Sports Amenities in Llandegfan in the Plan)** - this issue was left in the hands of County Councilor, Mr Alun Roberts.

- 1605.4 **White Lines near Pant Bach** - Cllr Alun Roberts confirmed that the work had been completed.

The Highways Department were happy with the scheme in principle and members of the Council AGREED that they would take responsibility and insure the equipment, Ttotal spend (£ 2,795).
