MINUTE 1555.2017. WELCOME AND DECLARATION OF INTEREST.

- 1555.1 The Chair welcomed Cllr Idris Alan Jones to the meeting.
- 1555.2 **Declaration of Prejudicial Interest.**
 - 1555.2.1 Cllr John Wyn Griffith declared a prejudicial interest in the planning applications listed as he was a member of the Planning Committee.
 - 1555.2.2. Interest was expressed by Cllr Alun Roberts in the Consultation on the modernization of schools in the Seiriol area as he was a member of the Governing Body of Beaumaris School but the personal interest was not prejudicial and therefore took part in the item.
 - 1555.2.3. Cllr Eurfrlyn Davies declared an interest in Llandegfan CPD funding application as he was the Chair of the Football Club. The interest was prejudicial and therefore he left the meeting when the item was discussed.

MINUTE 1556.2017 COUNTY COUNCIL'S PRESENTATION - EXTRA CARE HOUSES – SEIRIOL WARD.

- 1556.1 Ms Llinos Medi (Leader of the County Council) together with Mr Alwyn Jones and Ms Elin Parry were welcomed to the meeting.
- 1556.2 They gave a brief outline presentation and planning for almost half an hour about both the design plus a video presentation and all members had the opportunity to ask them relevant questions. It was stated that funding the scheme will come via the County Council's Housing Revenue account. 39 Care Homes will hopefully be built in the Seiriol area by the Beaumaris School site and the scheme is expected to start within 3 years. It was stated that any applicant will need to be in need of supported care and be at least 60 years old and over who have spent a lifetime on the Island or with strong links on the Island. It was reported that full details of the consultation were on the County Council's website.
- 1556.3 The Chair thanked the three of them for coming to the meeting and sharing the information with the members with the hope of working closely in the coming months.

MINUTE 1557.2017. COUNTY COUNCILOR'S REPORT.

- 1557.1 **Caerau Planning Application** - it was noted that neighbours had become unhappy with the development because the applicant was running a business from the site.
- 1557.2 **Gwel Eryri Signage at 32 Gwel Eryri** - it was noted that the sign had been relocated following cutting the hedge.

It was stated that Ysgol Beaumaris was to close and parents will have the option to take their child(ren) either to Llangoed School or Llandegfan School and to federate the TWO Schools and appoint an ONE headteacher for the TWO Schools. It was recommended that £700k would have to be invested at Ysgol Llandegfan to do this but it was felt that more expenditure is required. Members anticipated a battle from the current parents with children at Beaumaris School and it is expected to receive a consultation during the month.

MINUTE 1563.2017

HIGHWAYS MATTERS.

- 1563.1 **Signs near the Llidiart y Parc Crossing** - it was noted that signs near the site indicate a low bridge leading past Baron Hill had been moved causing problems with further damage to the sign at the crossroads and the County Councilor had written to the County Council in order to resolve the situation.
- 1563.2 **White Lines near Pant Bach** - again requested that the Highways Department accept and resolve the situation.
- 1563.3 Complaints and poor condition were reported following the recent hedge cutting around the village.
- 1563.4 Following notice in the October meeting that a litter bin was needed to be located along Lon Ganol in order to resolve the situation, it is understood that the annual cost of £ 150.00 will be paid as an additional bin charge and the waste management department required the exact location as quickly as possible to carry out a risk assessment at the chosen site. Proposed and seconded (JG / ET - 6/3) to proceed with the application.
- 1563.5 It was noted that the Dog Bin had still not been relocated near Llandegfan Church.
