1646. MATTERS ARISING FROM THE MINUTES.

- 1646.1 **Seiriol Extra Care Housing** - No further report.
- 1646.2 **Seiriol Area School Modernization Report** – A further consultation started on the 22/5/2018 and will end 2/7/2018.
- 1646.3 **Flashing Road Speed Signs near Llansadwrn Playground** - a second application to fund the purchase of the equipment has been submitted.
- 1646.4 **Layby between Llandegfan and Old Village** - it was confirmed that the parking restriction signs following the site traffic order had been installed. However, the possibility of reinstating the recycling skip was required.
- 1646.5 **Road Holes near Lon Plas, Bron y Felin, Bont Cottage & Lon Ganol, Llandegfan** - members' concerns that the standard of filling holes along the above lanes had not been acceptable had been reported and duly noted by the Highways Department.
- 1646.6 **New Projector to Hall** - in hand.
- 1646.7 **Lights above the Snooker Board** - report that the matter is in hand.
- 1646.8 **The Hall's British Gas Bill** - the Clerk reported that the bill of £ 8,500 was receiving attention.
- 1646.9 **Playing Field Grass Cutting** - it was noted that the piece that needed to be cut in Llansadwrn as well as around the boundaries of the two playing fields had been done.

1647. FINANCIAL MATTERS.

- 1647.1 The Clerk gave a full report on all the Council's and Parish Hall Payments & Receipts for May 2018 and this was signed by the Chairman.

1647.2 The Internal audit report of the findings and recommendations of Chatered Accountants, IG Jones & Co, Llangefni, was read outlining that the Clerk's salary was paid correctly but that the RTI regulations were not sent online promptly and accurately and that this could lead to fines from the HMRC. Also one cheque worth £ 25.00 had not yet been presented for payment and the need to consider cancelling this payment with the bank.
