1836. WELCOME.

1836.1 The Chairman, Cllr Idris Alan Jones, welcomed everyone to the meeting.

1836.2 He was pleased to learn that there was not too much damage following the latest storms (Ciara/Dennis).

1836.3 He was very pleased to see that Councillor Nia Foulkes had improved after her illness in January.

1836.4 Councillor Eurfrlyn Davies was congratulated on the privilege of having Llandegfan Football Club name their ground ‘Parc Eurfrlyn’, in recognition of his work as co-chair of the club.

1837. DECLARATION OF PERSONAL / PREVIOUS INTEREST.

1837.1 Councillor Mr John W. Griffith declared a personal and prejudicial interest in the list of planning applications being discussed as he was a member of the County Council's Planning Committee - he had been granted special dispensation to remain in the room in order to listen to comments but did not participate in the discussions.

1838. CONFIRMATION OF MINUTES OF MEETINGS

- 1838.1 Full Council Meeting – 15 October 2019 – it was confirmed and signed that the minutes were true and accurate (EGD/AR).
- 1838.2 Full Council Meeting - 12 November 2019 - it was confirmed and signed that the minutes were true and accurate (GC/TC).
- 1838.3 Full Council Meeting - 14 January 2020 – it was confirmed and signed that the minutes were true and correct (EGD/NF).

1839. MATTERS ARISING FROM PREVIOUS MEETINGS.

- 1839.1 Llansadwrn Flood Alleviation scheme – it was noted that the work had completed. Due to the inclement weather and the condition of the field, it was decided to leave the field closed to allow the grass surface to recover and to re-open at the end of May 2020.
- 1839.2 Lon Fain – it was noted that some of the lights were not working – Councillor Alun Roberts to contact the County Council's Footpath Department.
- 1839.3 Anti Social behaviour – following the meeting held in October, it was agreed to extend an invitation to the Police to our next meeting in order to receive an updated report.
- 1839.4 New Chairs for the Hall – await the response and decision of the Anglesey Charitable Trust.
- 1839.5 See-Saw Matting, Llandegfan Playfield – confirmation that the work has been done.
- 1839.6 New Notice Board Location – the clerk informed the Council that d that he was expecting a response from the County Council's for consent that the proposed site adjacent to the Old Post junction was acceptable.
- 1839.7 Bus Shelter Seating – the clerk confirmed that this work is due to commence in April.

- 1839.8 Llansadwrn BT Kiosk – The clerk informed members that he had signed the agreement with British Telecom for the Community Council to take over the responsibility of the Kiosk and to install a defibrillator machine in due course in accordance with the outline specifications.
- 1839.9 Cleaning of the War Memorial - Councillor Nia Foulkes said that she had contacted Problast Limited based in Colwyn Bay asking them to visit the memorial and to prepare an estimate to clean the memorial to the required standards.
- 1839.10 Second World War celebrations – after discussion the Council agreed to organise a short service and activity in the Parish Hall on Friday morning 8/5/2020 commencing at 11:00am.

1840. FINANCIAL & ADMINISTRATION OF COUNCIL.

- 1840.1 To correct the minutes of the Finance Committee Meeting held on the 12 November 2019 - it was confirmed and signed that the minutes were true and accurate (AR/JD).
- 1840.2 Bank Reconciliation of Account balances up to 31.1.2020 & Approval of February payments 2020 – the Clerk gave a full report of the Council's accounts payments and receipts for the month of January 2020 and payments due for February 2020 and the Chairman duly signed the report including the bank reconciliation and the council bank statements.
- 1840.3 Additional Donation – Wales Air Ambulance (S137) – proposed and seconded (EGD/AR) that the Council donated £250.00. Approved.

1841. PARISH HALL FINANCE & ADMINISTRATIVE ISSUES.

- 1841.1 **Bank reconciliation of account balance up to 31.1.2020 and the Approval of the Parish Hall Account Payments for February 2020** -the clerk gave a full report of the Hall's payments and receipts for the month of January 2020 together with payments due February 2020 and the report was duly signed by the Chairman including the Bank reconciliation and Parish Hall Account statements.
- 1841.2 There was a lengthy discussion about the standard and use of the flasks and the need to purchase new ones. The Clerk and Councillor Nia Foulkes expressed strong concerns that the current situation of purchasing new flasks every 6 months cannot continue and that a decision needs to be made either way on a better way forward. It was resolved that Councillor Tom Cooke should make enquiries and was set a budget of £150.00 and report back to the next meeting.
