- 1825.1 The Chairman, Cllr Idris Alan Jones, welcomed everyone to the meeting and wished all members a Happy New Year.
- 1825.2 The Council expressed its deepest sympathy to County Councillor Mr Carwyn Jones and his family for their recent bereavement

- 1816.1 Councillor Mr John W. Griffith declared a personal and prejudicial interest in the list of planning applications being discussed as he was a member of the County Council's Planning Committee - he had been granted special dispensation to remain in the room in order to listen to comments but did not participate in the discussions.
