1944 ADRODDIAD Y CYNGHORWYR SIROL.

Rhoddodd y Cynghorydd Alun Roberts adroddiad llafar ar y materion canlynol;

- 1. PENHESGYN** - bydd Canolfan Ailgylchu Penhesgyn ar agor ddydd Sadwrn ar sail apwyntiad sy'n golygu y bydd y cyfleuster ar gau am un diwrnod yn ystod canol wythnos. Lleisiodd cynghorwyr pryder ynghylch y broses o gofrestru a gwneud y penodiadau hyn a rhoddodd y Cynghorydd Roberts ymrwymiad y bydd yn trosglwyddo'r pryderon hyn i'r Awdurdod Lleol.
- 2. AIL AGOR YSGOLION** - bydd y broses o ailagor ysgolion ar gyfer disgyblion ym mis Medi yn cael ei syfrdanu'n raddol ac mae gwaith yn mynd rhagddo i sicrhau y bydd ysgolion yn cael eu gwneud yn ddiogel cyn 3 Medi. Minutes of the Virtual Council Meeting held by video conference,
WEDNESDAY, 12th AUGUST 2020.

MINUTE:

- 1913. PRESENT:**
Councillors Mr Idris Alan Jones (Chair), Mr Alun Roberts, Mrs Nia Wyn Foulkes, Mrs Nia Wyn Jones, Ms Joan Kirkham, Mr Tom Cooke, Mr John Wyn Griffith, Mr John Griffiths, Mr Gareth Griffiths & Mr J Alun Foulkes (Clerk).
- 1914. APOLOGIES:**
Councillor Mrs Jean Davidson & Mr Eurfrlyn Davies.
- 1915. WELCOME.**
- 1915.1 The Chair welcomed everyone to the meeting, in particular, Mr Hilary Kehoe & Mrs Rebecca Pritchard (Menter Môn).
- 1915.2 He thanked the clerk again or his hard work in preparing and providing a comprehensive agenda to the members of the Council.
- 1916. DECLARATION OF PERSONAL/PRELIMINARY INTEREST.**
- 1916.1 Councillor Mr John Wyn Griffiths declared a personal interest that was prejudicial to each planning application (item 25.1 and 25.2) as he was a member of the County Council's planning committee. He took no part in the discussions and the Council's comments.
- 1917 CWLWM SEIRIOL REPORT - Proposed Grazing - Cyttir Local Nature Reserve, Llandegfan.**
- Mrs Hilary Kehoe (Pont Cymru) gave a presentation regarding and proposed grazing on Cyttir Mawr - she explained her role in that Conservation Grazing for Wildlife was jointly working with Cwlwm Seiriol and gave a full explanation as to why grazing was playing an important role within our environment. She then went on to say that the extent of heathland at Cyttir had reduced over time and was in a degenerative state and that grazing and cutting back would encourage growth again. Open areas existed at the Reserve and these also needed maintenance to encourage the resurgence of wild flowers. A proposal was put forward for 4 Carnedd Ponies to graze on the south side of the Nature Reserve enclosed within a permanent boundary netting fence line covering an area of 245 metres including a 190 metre electric tape fencing (elipex) and this would cost around £2,500 covered by the Cwlwm Seiriol project. Agreed unanimously (JG/JWG) and the Chair thanked Mrs Kehoe for her presentation and sharing this information with the Community Council.

- The clerk had no further developments to report at the moment.
- 1919 CORRECT & APPROVE COUNCIL MEETINGS:**

- 1920 LLANSADWRN FLOOD ALLEVIATION SCHEME.**
- The Clerk's reported that site repairs had been completed and that the grass now needs time to grow before the full use of the playground can restart. **In the meantime, and in the interests of health and safety this area of the playing field will have to remain closed. The Clerk also said that arrangements were in hand to install a hand sanitizer near the entrance and members thanked the Clerk for this Work.**
- 1921 REOPENING OF THE PLAYGROUNDS.**
- Following what was said at the July meeting, the Clerk said that the Welsh Government had lifted restrictions to allow playing fields to be re-opened on the 20th July but that both villages had to wait until 1/8/2020 for the Clerk to complete all the necessary arrangements, a risk assessment and other recommended guidance. It was noted that both Playing Fields must be maintained as well as keeping track and washing all equipment on a weekly basis. It was also noted, with disappointment, that not everyone had adhered to the rules and several examples and events that had happened for weeks now were highlighted and that litter needed to be picked up several times in order to keep the site tidy.
- 1922 LON FAIN.**
- Following on what was noted that the lights were working but that the glass of 8 & 9 lamps needed attention, the Clerk had contacted the Footpath Section of the Highways Department. It was noted that a response had been received by email from Mr Arwel Evans (County Council's Footpath Officer) and that he had brought the attention of colleagues in the Lighting Section in order to repair the damage.
- 1923 NEW BUS SHELTER SEATING.**
- The clerk said that he had no development to the enquiries and therefore consideration had to be given to contacting other contractors for a price in order to report back to the next meeting.

BT KIOSK – LLANSADWRN.

The Clerk confirmed that the Kiosk was now the property of the Community Council and it will be necessary to proceed with the installation of a new defibrillator inside the kiosk in accordance with the agreement. He had been unable to progress at this time as he had failed to contact and speak with County Councillor Carwyn Jones.

ADDITIONAL DEFIBRILLATOR INSTALLATIONS.

Mr Tomos Hughes was welcomed to the meeting and proceeded to give members a full description of his role in supplying and fitting Defibrillators and that he jointly works in partnership with the Betsi Cadwaladr Health Board and the Welsh Ambulance with the former funding the project. The Clerk then reminded members what had previously been discussed and agreed upon and that it was his recommendation to enter into a contract with Mr Hughes to fit the Defibrillator in the old BT Kiosk in Llansadwrn and to explore the possibility of installing an additional TWO machines located near Allt Cichele and somewhere in the Hen Bentref. The cost of fitting each machine would be in the region of £1,800. **Proposed (NF) and Seconded (AR) that the Community Council proceeds and that consideration could be given two other sites, 1 in Llandegfan and 1 in Llansadwrn out of next year precept. Agreed unanimously.**

Dog Dispenser & Bags Project.

Following the full report received in July, the Clerk said that he had met Mr William Stockwell from the County Council's Waste Department and had agreed to install and locate 3 Dog Dispensers around the village of Llandegfan where bins were already in place (Lon Ganol/Llandegfan Church/Pencefn Hotel). It is expected that this work will have been undertaken by the end of September 2020.

‘Dangerous’ Parking in Llandegfan

The Clerk had received an email from a disturbed local resident in Llandegfan who was very concerned with the dangerous parking currently existing on the sharp corners near the Playground and Bron Llewelyn entrances plus the brow of Trem Arfon and that an accident was waiting to happen. **It was resolved that County Councillor Alun Roberts would contact the County Council's Highways Department and Ms Llinos Davies, NWP Chief Commissioner for Anglesey.**

County Councillor Alun Roberts also brought to members attention that there was speeding along Lon Brynteg and accidents at the bottom of the lane had been reported. He had already spoken with Officers of the County Council and that there were good solutions suggested to remedy the situation. **It was agreed that Councillor Roberts continues to liaise with the Highways Department and local residents and to include Lon Allt Bryn Mel as part of these discussions.**

COUNTY COUNCILLOR REPORT.

Councillor Alun Roberts gave a verbal report on the following issues;

1 Penhesgyn Recycling Centre will be open on Saturday on an appointment basis meaning that the facility will be closed one day during midweek. Councillors voiced concerns over the procedure in registering and making these appointments and Councillor Roberts gave an undertaking that he will take back these concerns to the Local Authority.

2. REOPENING SCHOOLS - the process of reopening schools for pupils in September will be staggered and work is ongoing to ensure that schools will be made safe prior to the 3rd September. Councillor Roberts stated that Transport will also be a problem. Finally, it was his opinion that the 'A' Level & 'O' Level Exam results due will present a problem and that the grading process implemented had been flawed.

3 COVID19 - large numbers of people are now visiting Beaumaris and many are not complying with the social distance guidances and concerns that a second wave will become imminent in view of current increases seen in various parts of England. Although testing continues to show an increase in more positive cases, the overall casualties in our area has been stabilised. A general discussion on the testing process then followed and the main consensus among members was that this was not proving to be very effective. The Chair thanked Councillor Roberts for his precise report.
