- 1976.1 The Chairman welcomed all members to his first monthly meeting as the new Chairman, in particular, to PCSO Dave Webster who was attending in order to provide members with the latest updates on community policing matters.

- 1978 REPORT FROM PCSO DAVE WEBSTER.**
PCSO Dave Webster gave members a verbal report on the following issues:
- 1978.1 Report of anti-social behaviour from a small group of youngsters congregating around the Parish Hall and around the village and that these incidents had been dealt with appropriately.
- 1978.2 Report of Theft at Melin Cadnant and Fields near Stad Pencae – this investigative work was still in progress.

1978.3 A general discussion then followed regarding protocols to follow for future

incidents and PCSO Webster reiterated his continued support to the Community Council but, again, reminded members that the message is clear – to monitor and report such incidents themselves or via the Clerk so that they can be logged at Police HQ, otherwise an incorrect record will be maintained.

1978.4 The members also shared their concern with the problem of speeding and parking in the village and PCSO Webster acknowledged the concerns and gave a general response as to the way forward. The Chair also mentioned that reducing the speed limit to 20mph is in the pipeline for all areas where there are Primary Schools on the Island and perhaps this would then be the ideal time to discuss the matter in more detail. **AGREED and a request to place this matter on a future agenda when the opportunity arose.**

1979 **Dangerous' Parking in Llandegfan**
The Chairman reported that he had arranged and conducted a site visit with an Officer from the County Council's Highways Department to explore the various options that can be considered and again this was not a quick fix and members once again **AGREED to place this matter on a future agenda.**

The Chair thanked PCSO Webster for attending and sharing the information and hope to see him in the New Year.

1985 New Bus Shelter Seating.

The Clerk said that no local firms were forthcoming to assist the Council and that he had phoned Macemain Amstad Manufacturers who initially installed the Shelters. They had agreed to provide the Council with an estimate within 48 hours of this meeting. **Member approved the Clerk's actions and a further report would be given at the next meeting.**

1986 Defibrillator Installation Scheme.

Following a brief telephone conversation with Mr Tomos Hughes, minor issues remained with the completion of the defibrillator in Llansadwrn and once this had been resolved, arrangements could begin with installing the logo of Alun Griffiths Contractors and arrange a photo opportunity.

1987 Dog Bag Dispensers.

Works to install the dispensers had not yet been completed despite having sent payment to the County Council. **The Clerk to chase the matter up.** County Councillor Carwyn Jones made a request to consider the installation of a dispenser in Llansadwrn. **Agreed – County Councillor Carwyn Jones to make the necessary arrangements with the County Council.**

1988. **Llandegfan Footpath No 12 & 14 – Cyttir Bach.**
