The Chairman extended a warm welcome to everyone to the meeting.

The Clerk reminded Council that it was nearing 6 months and time again to approve the continued absence of Councillor Jean Davidson from meetings as she did not have the means to attend on a virtual basis. Council approved her absence in accordance with s85(1) of the LGA1972.

Councillor Mr John Wyn Griffith declared a Personal Interest that was prejudicial in all planning applications (**Agenda Item 6.1> 6.2**) as he was a member of the County Council's Planning Committee. He took no part in the Council's discussions and observations.

Miss Carys Thornton was welcomed to the meeting by the Chairman and she duly gave members a history of her experience and the contribution she can offer the Council. There was an opportunity to ask relevant questions and to thank her for showing interest. The Chair then asked her to leave the meeting but to remain online to allow Members to confirm their decision.

Decision: The Clerk confirmed that Mr Peter Williams had withdrawn his interest in becoming a member of the Community Council. It was, therefore, agreed unanimously (GG / JK) to elect Miss Carys Thornton to fill the vacant seat and to ask the Clerk that she completes and signs the standard declaration form to become a Councilor as soon as possible and to respect the Council's Code of Conduct.

- 2103 To Receive & Approve Council Accounts - 2020/2021.**
The Clerk gave a brief report of all payments and receipts a year including the explanation of various differences in income and expenditure. Due to the circumstances of Covid19, there was an underspend of £ 5,707. He then advised that the Council had £12,496 in reserve at the end of the financial year but £4,000 had not been spent on work to install the bus shelter seating x4. He said that other reserves totalling (£ 2,700) was for improvements and repairs to Llansadwrn playing field and this will be expected to have been spent during 2021/2022. Motion (JG) and seconded (EGD) that the Council accepts the accounts and they were approved unanimously.
- 2104 To Receive & Approve the Parish Hall Accounts - 2020/2021.**
The Clerk had prepared a brief and simple report of payments and receipts a year including the various differences in income and expenditure. The Covid19 pandemic has had a huge and terrible impact on the hiring of the hall during the year. However, he thanked the Welsh Government and the County Council for their subsidies totalling £18,680 during the year which has assisted towards setting the budget funding for this year as well as the Council's contribution which explains why the Council had £32,000 in the account. However, £18k expenditure is expected following improvements to the men's toilet and that careful spending is needed during the year to sustain the position. On the whole, he was happy that the Hall had adequate reserves in hand for the forthcoming 12 months. Finally, the Clerk said that he had re-negotiated agreements with British Gas for the hall for the next two years to keep costs as low as possible. Proposal (JK) and seconded (IS) that the Council accept the accounts and this was approved unanimously.
