Minutes of the Footpaths Sub Committee Virtual Meeting held via the Zoom Video Conference Link on MONDAY, 15th MARCH 2021.

MINUTE:

- 1 PRESENT:**

- 2 APOLOGIES:**
Cwlwm Seiriol: Mr Simon Hunt & Mrs Delyth Phillips.
- 3 Welcome.**
The Chairman welcomed everyone to the meeting.
- 4 Footpath Cyttir Mawr to Twll Cacwn**
The path suffers from poor signage in several places. The steps and handrail need replacing in one location and consideration must be given to remove and replace a couple of gates and stiles.
- 5 Footpath Twll Cacwn to Bachau.**
Confirmation had been received at the last Full Council meeting that a County Council order had been made to divert footpaths 10 & 11 away from entering the farmyard at Bachau and to erect the appropriate way marking signs.
- 6 Footpath Bachau to Tyddyn Bach**
This path also suffers from poor signage.
- 7 Tyddyn Bach to Cyttir Mawr.**
Signage again needs to be addressed along with a couple of gates and stiles plus the raising of the height of the boardwalk that is under water.

RESOLVED: Confirmation that Rebecca Pritchard (RP), on behalf of Cwlwm Seiriol would arrange for total costing of all improvements needed to Footpaths 4, 6 & 7 and provide the Clerk with a report prior to the next meeting in order to consider who will pay for this expenditure.
- 8 Tyddyn Isaf to Twll Cacwn**
RESOLVED: Confirmation that volunteers would look at sorting out the steps from Lon Ganol. However, suggested that a wider cut to the overgrowth is needed next year.

- 9 **Cyttir Bach Footpath.**
Confirmation that Cwlwm Seiriol have paid to remove and install new boardwalks and well over 100 anti-slip strips with thanks.
RESOLVED: Confirmation that the Community Council would look into financing the cost of extra handrails along this path.
- 10 **Llyn y Gors Footpath.**
It was reported that works was needed to raise the level of the path in order to solve the problem with the flooding of the path for much of the year. Intention is to raise the level by approximately 400mm above current level using stone and soil from the fishing lake site and that the owner of the lake has kindly offered the material for free.
RESOLVED: Confirmation that Delyth Phillips had provided the Clerk with a copy of the estimate in excess of £20,000.
- 11 **Melin Cadnant Footpath.**
The Clerk reminded members of discussions that took place between Ms Jean Williams of Pennant, Llandegfan and the County Council and her proposals to re-route the path of which the Community Council were in full support following a meeting held with her in September 2019. The Clerk reported that he has heard of no developments since this meeting.
RESOLVED: Confirmation that the Clerk looks into the matter and report back to the next Footpaths Committee.
- 12 **Lon Fain Footpath.**
It has been reported that TWO broken lights along the path had not yet been repaired despite a request from the Community Council and that there has been a complaint regarding overgrown hawthorn and crab apple trees along the path.
RESOLVED: Confirmation that the Clerk would contact the County Council again regarding the broken lights. However, the County Council had cut the overgrowth, albeit to a very poor standard. The Clerk to arrange a tidy up of the site once the nesting season had finished.
- 13 **Ty Gwyn Footpath.**
It was reported that part of the path was now flooded and that the steps leading down to the river had eroded and needed attention.
RESOLVED: Confirmation that JG & RT to walk the path and provide a report to the Clerk with photographic evidence to determine what costs are involved.
- 14 **Fferm Rysgol Footpath**
RESOLVED: Confirmation that IAJ & ED had walked the path and provided a report to the Clerk with photographic evidence to determine what costs are involved. The Clerk to arrange the necessary works as soon as possible.

- 15 **Footpath 16 (Pilot Path) & Footpath 27 (Fodol)**
RESOLVED: Confirmation that JG had walked both paths and were found to be in good order. However, better signage is needed for Footpath 27 & also Footpath 26 leading to Y Wern.

- 16.1 **Footpath 38 (Trefor Wen) – RESOLVED: Confirmation had been received at the last Full Council meeting of the County Council intention for an order to divert the footpath away from entering the farmyard close to Trefor Wen and to erect the appropriate stiles and way marking signs. The Community Council were in full support of the proposals.**
- 16.2 **Footpath 41 (Trefor Plas) – Councillor Mrs Nia Jones (NJ) raised concerns that the floor of the path was in a poor state. The Clerk confirmed that he had reported this to Mr Arwel Evans of the County Council last year.**
RESOLVED: Clerk to send an email to remind the County Council Officer.
- 17 **Digital Mapping.**
RESOLVED: Clerk to update the website with the relevant new map.
- 18 **Date of Next Meeting – 10th MAY 2021.**
