Minutes of the Footpaths Sub Committee Virtual Meeting held via the Zoom Video Conference Link on MONDAY, 17th MAY 2021.

- 2** **APOLOGIES:**

- 3** **Welcome.**
The Chairman welcomed everyone to the meeting.

- 4** **Footpath Signage.**
It was acknowledged that several paths were suffering from poor signage in several places and some stiles needed urgent repairs or replacing.
RESOLVED: In order to make progress it was agreed that Rebecca Pritchard (RP), on behalf of Cwlwm Seiriol would arrange for total costing of all improvements needed and provide the Clerk with a report prior to the next meeting in order to consider who will pay for this expenditure.

- 5** **Cyttir Bach Footpath.**
Confirmation with thanks that Cwlwm Seiriol have carried out the extra and installed extra handrails along this path.

- 6** **Melin Cadnant Footpath.**
The Clerk had prepared a report and contacted the County Council who have agreed to arrange the necessary remedial repairs to the Path.

- 7** **Lon Fain Footpath.**
It has been reported that TWO broken lights along the path have still not yet been repaired. The Clerk confirmed that he had contacted the County Council again regarding the broken lights. The Clerk had also received a quote of £140.00 to tidy up the bottom area of the path following the recent mess left and members agreed to accept the quote.

- 8** **Ty Gwyn Footpath.**
The Clerk thanked Mr John Griffiths for providing the photographs. He confirmed that he had prepared a report and contacted the County Council who have agreed to arrange the necessary remedial repairs to the Path.

- 9 **Fferm Rysgol Footpath**
 Mr Idris Alan Jones and Mr Eurfryn Davies to revisit the path and to determine (dependent on usage) whether the Community Council must consider spending around £750 into improving the Lon Ty Newydd Access.
RESOLVED: Further report at the next meeting.
- 10 **Llansadwrn Footpaths.**
- 10.1 **Footpath 38 (Trefor Wen) – RESOLVED:** Confirmation had been received that the County Council had issued an order to divert the footpath away from entering the farmyard close to Trefor Wen and to erect the appropriate stiles and way marking signs.
- 10.2 **Footpath 41 (Trefor Plas) –** Councillor Mrs Nia Jones (NJ) raised concerns that the floor of the path was in a poor state. The Clerk confirmed that he had reported this to Mr Arwel Evans of the County Council last year. The Clerk had prepared a report and sent for the attention of the County Council Officer. Reply received that they will not replace the board walks or improve the surface.
RESOLVED: to monitor the position.
- 11 **Digital Mapping.**
RESOLVED: Clerk to update the website with the relevant new map.
- 12 **Date of Next Meeting – September 2021.**
