**1 PRESENT:**

**2 APOLOGIES:**

**3 WELCOME**

The Chairman extended a warm welcome to every member to the meeting and wished everyone a Happy New Year and to hope that this will be a better year for everyone. He thanked Councillor Nia Wyn Jones for arranging the delivery of a small gift to Councillor Nia Foulkes for all her work at the Parish Hall since the beginning of the pandemic and this was duly appreciated by Councillor Foulkes. The Chairman also mentioned the sudden passing of Mr William Hughes, Cae'r Ffynnon (husband of Mrs Wena Hughes - Caretaker next door) and the meeting expressed its sincere condolences to the family.

**4 To Dissolve the Finance Sub-Committee.**

- 4.1 In view of its importance to the Council and to avoid the duplication of work, the Clerk requested members of the Council to consider dissolving the Finance Sub-Committee under Standing Order 4d (xii) & Standing Order 10 so as to allow every member to attend.

**DECISION:** Members agreed unanimously with the Clerk's recommendation.

**6.2 DECISION:** Also agreed unanimously that the Council purchases Welsh/English dictionaries again this year for those children leaving the Llandegfan Primary School for Secondary education.

## **7      Review Clerk's Wages & Contract of Employment.**

The Clerk had provided the Council with information appertaining to the NALC Pay Scales dated April 2020 for Part-time Community Council Clerks. Given the current role profile, specifications and requirements, the relevant Grade to be applied should be Grade LC2 (point 28) = £32,234pa (pro rata) (35 hours @ £16.75 per hour). Annual Salary would be £7,035 meaning £586.25 gross per month before deduction of PAYE £117.25 leaving £469.00 pm net, an increase of £11.00 per month on the current wage.  
**DECISION:** Members approved the Clerk's recommendations unanimously and requested that a draft contract of employment is made available at the April meeting for approval.

## **8      Budget Review & Monitor – 2019/2020 & 2020/2021.**

Following the Clerk's precise report to the Finance Committee, it was recommended that the level of the precept is increased by 2.86% from £31,500 to £32,400. This was the first increase in 5 years. Proposed by (IAJ) and seconded by (TC) that the Council approves the increase.

**DECISION:** Proposed increase agreed unanimously. The Clerk to ensure that full details of the Precept are on the Community Council website.
