**2248**

**Welcome & Chairman's Report.**

**2248.1**

The Chair gave all Councillors a warm welcome, especially Mrs Rhian Hughes from Seiriol Alliance.

**2248.2**

**Lon Ganol** – confirmation that he has raised the road issues and problems with the Authority's Highways Department following the closure of the road through the old village and the urgent need to carry out a full tree survey and address the water by the lake at Pen Parc once the flood alleviation works have been completed.

**2248.3**

**Hen Llandegfan Flood Alleviation Scheme** – gave a full report on the works to date including a site visit with Contractors earlier this week. The Scheme is expected to last for at least another 3 weeks and he praised the Contractors for their conduct and co-operation with local residents. He also mentioned initial problems with the School Bus and normal Bus Services that have now been resolved.

**2248.4**

**Allt Cichle** – received complaints of obstruction following the demolition of 'The White House' at the bottom of Allt Cichle. He confirmed that the County Council have contacted the Developers to resolve the matter. The Clerk did point out that this was one of the concerns submitted by the Community Council within the Planning Application.

- 2248.5** **Bryniau Duon Estate, Hen Llandegfan** – received complaints regarding the poor state and appearance of No 4 on the estate and that there is a major ‘rat’ problem. Councillor Eurfrlyn Davies reported that the dwelling is owned by the Church in Wales and that this issue had been raised with them several years ago.
- 2248.6** **Defibrillator** – confirmed that a new defibrillator has been installed at the Parish Hall and he duly thanked the Clerk for this hard work.
- 2248.7** **Lon Filltir** – report of illegal fly-tipping along the route.
- 2248.8** **Road Surfacing** – the Clerk raised concerns that there was an urgent need to repair the road surface between the Church and the Old Village once the Flood Alleviation Scheme had been completed and produced photographic evidence to the contrary. He was also concerned with the road surface between the Maldwyn Junction all the way along to the Cae'r Gelach and Gerddi Hafod Lon Estates entrances and again provided members with photographs. The members were made aware that the County Council has an annual list of routes needing attention and a request was made to the Clerk to write to the Authority for these routes to be included on the 2022/2023 list and to copy the County Councillors with this request.
- 2248.9** **Trem Arfon / Village Hall** – the Clerk raised the parking issues once again at the brow of the Hill at Trem Arfon having nearly witnessed a road accident and he had sent an email to the local PCSO with a copy to the Chair. Councillor John Griffith again raised concerns with the parking outside the Parish Hall that was causing an obstruction for vehicles attempting to enter and leave the estate opposite. The Chair agreed to take the matter back to the County Council’s Highways Department with a view of placing ‘No Parking’ signs at this location.
- 2249** **Presentation by Mrs Rhian Hughes – Seiriol Alliance.**  
The Chair again welcomed Rhian to the meeting. Rhian gave a full description of her role and responsibilities since becoming the Intergenerational Officer last Summer and a report of the work she has undertaken. Her main priority at the moment is to attempt and engage with local Schools and Youth Clubs and create various activities and projects that could be of benefit to the local youngsters. At the end of the presentation, members were given the opportunity to ask her questions regarding her role and what she hopes to achieve. The Chairman thanked her for attending the meeting and wished her every success in the role.
