**Rural Housing Facilitator Introduction.**

Following a report at the September meeting, Miss Chloe Tudor Jones of Grŵp Cynefin and County Council Housing Officer, Mr Trystan Evans was welcomed to the meeting. The purpose was to introduce a site in question at Llandegfan near the boundaries of the Gwel Y Llan estate for the building of affordable housing following the response of the village residents' questionnaire. After the opportunity to see the scheme and ask them questions about the plan, it was noted that an open day in the hall will be arranged before Christmas for the benefit of the community and to be able to gain a better understanding of the housing needs in the village.

The Chair thanked both of them for coming along and looked forward to the open day.

- 2346** **Public Consultation Response Pre -Proposed Tourism Development Planning Application at: Wern Farm, Pentraeth Road, Menai Bridge. 14th September to 15th October 2022.**  
Members expressed strong doubts about the size and location of the proposed development which is considered an over development of agricultural land in the open countryside contrary to the relevant policies of the Local Development Plan and decided to officially answer once full application details were received.
- 2347** **Playground Matters.**  
. Clerk is still waiting for an estimate from Messrs GL Jones & Co, Bethesda for repairs to Llandegfan playground equipment.  
. Clerk has received a quote of £1811.00 & VAT from Playdale Playgrounds for the repairs of other playground equipment in Llandegfan. **Agree to pay (AW/TC).**  
. The Clerk was concerned about the condition of the top piece of the playing field in Llandegfan and will need to arrange to have the area re-turfed as soon as possible to eliminate any potential risks. It was noted that the matter had been raised and included in the last two annual play area inspections. The Council agreed to allow the Clerk to contact the relevant contractors and receive an estimate.  
. Clerk is still expecting a response from the new Chief Executive of 'The Association' asking them to consider increasing the grant awarded to £ 28,000 following an increase in costs of the new equipment needed at Llansadwrn Playing Field.

**2349.1** Full application for the demolition of an existing shed and erect a new holiday unit as well as creating a new entrance and driveway and associated development at: **Gwenallt, Llansadwrn - FPL/2022/248.**

- Consider that the proposal by virtue of its location in a small residential area will primarily be detrimental to the area's residential character and contrary to the requirements of Tower 2, PCYFF1, PCYFF2 and PCYF policies 3 Local Development Plan in Anglesey and Gwynedd.
- Consider that the proposal will have a detrimental effect on the amenities of the neighbouring properties because of its proximity to the border in contravention of the requirements of the PCYF 2 policy of the Anglesey and Gwynedd Joint Local Development Plan and the Council contained in the Planning Guidance Supplementary in the Supplementary Planning Guidance: Design Guide for the Urban and Rural Environment (March 2008).
- Concerns remain that there is no need to create additional vehicle access for this type of proposed development on a narrow and busy road and believe that the development is contrary to Tower 2 policies and while 4 of the Anglesey and Gwynedd Joint Local Development Plan.
