2453

Welcome.

All Councilors were welcomed to the meeting by the Chairman. He thanked Councilor Mr Alun Roberts for chairing the July meeting and explained the reasons for calling this meeting virtually. Finally, condolences were expressed to Councilor Mr John Griffith following the sad death of his wife, Beryl and the Councilors were asked to observe a minute's silence as a sign of respect. The Clerk confirmed that he had sent a condolence card to Councilor Griffith on behalf of the Community Council.

To Correct, Approve & Sign Minutes of the Last meeting.

Full Council Meeting – 12th July 2023 - motion (AR) and seconded (GG) that the minutes be approved and signed as correct. AGREED.

2455

Matters Arising.

2455.1

Allt Cichle - it was noted that resurfacing work is in progress. Also, it was noted of complaints received that overgrowth at the bottom of the hill was hiding the Llandegfan and Bus Stop sign on the A545 Beaumaris Road.

- 2455.2** **White Lines** - it was noted that work on repainting white lines on the road near Allt Cichle, Lon yr Eglwys and outside the School was also in progress.
- 2455.3** **20mph Speed Signs** – a further general discussion took place on problems following the implementation of the new 20mph speed limits that have been put in place and the effect this will now have on those who use their own vehicles responding as volunteers for the emergency services.
- 2455.4** **Arriva Bus Service** - a further report was received on the service, which, thankfully, does not affect Llandegfan, unlike other areas in the Seiriol ward. There was a general discussion following the expression of disappointment with Arriva's position in ignoring the needs in the more rural areas. Concern was also expressed, although a local Community Bus Scheme is being considered through the local Good Turn Scheme, this would come at a cost when people over 60 would receive a free bus ticket.
- 2455.5** **Cylch Cyttir** - it was noted the need to arrange a meeting as soon as possible.
- 2455.6** **Footpath Matters** - it was noted that a meeting is needed to be arranged as soon as possible.
- 2455.7** **Biodiversity Plan** - it was noted that a Policy Plan needed to be adopted as soon as possible.
- 2455.8** **Wern Farm Planning Application** - it is noted that the planning application has been called in before the Full Planning Committee of the County Council.
- 2455.9** **Ysgol Llandegfan Planning Application** - it is noted that the planning application has been withdrawn for the time being.
- 2455.10** **Glan y Menai Planning Application** - it is noted that the planning application has been called in before the Full Planning Committee of the County Council.

- 2455.11** **Llandegfan Parish Hall Matters** - a full report of the painting work was received and it was reported that Menai Cleaning will clean the floors at the end of October. Following the recent replacement of some of the roofing slates and observations received, the Clerk felt that the time had come to have a general inspection and survey of the roof and that the Parish Hall Management Committee should discuss this along with other building matters and appoint a Caretaker and Cleaner as soon as possible. **The Councilors resolved to approve the Clerk's recommendations.** Also, there was a brief discussion following the Clerk's report and concerns about the delay in receiving the County Council's subsidy (2021/2022) for the Hall's running costs
- 2455.12** **Llansadwrn Playground** - it was noted that the installation of new equipment had been completed for a month now . It was noted that a further estimate was needed in order to consider replacing the Football/ Netball equipment and that it was disappointing that there is a delay in waiting for subsidy money from 'The Association' in order to pay GL Jones & Co from Bethesda and that this was disrupting the Community Council's budget. **Resolved that County Councilor Mr Carwyn Jones contacts Celyn Edwards from the 'Association' with the release of the money.**
- 2455.13** **Annual Inspection of the Playgrounds** - it is noted that the inspection report needs to be considered and money allocated for any repair expenditure in the 2024-2025 budget.
- 2455.14** **Playground Grass Cutting Agreement** – **resolved to approve the Clerk's recommendation that a tendering price is needed for 2024/2025 in order to include it in the budget.**
- 2455.15** **Community Garden** - **resolved to approve the Clerk's recommendation to defer the purchase of the equipment and include in expenditure and budget for 2024/2025.**
- 2455.16** **Community Council Training Plan & Courses** - the Clerk had prepared and distributed the Council's required Training Plan in accordance with Section 67 of the Local Government Act and Elections (Wales) 2021 to be discussed and approved. **Councilors resolved to adopt the Scheme (JG/NF) with thanks to the Clerk and also made a further decision that perhaps attending any of the Training Course as a Council would be more favourable.**

The main topics discussed included a presentation of the Council's Plan and the Delivery Document by the Council's Chief Executive, Mr Dylan J Williams, a presentation by the Leader of the Council, Miss Llinos Medi on the financial constraints facing the County Council over the next 2-3. years which will have a detrimental effect on the services provided, a report by the Chairman of the Island's Standards Committee and finally a presentation by Miss Celyn Edwards, Chief Executive of the Association. County Councilor Mr Alun Roberts replied giving a full report (including statistics) on the impact and decisions facing the Local Authority.
