2499

Welcome.

The Chairman welcomed all Councillors to the first meeting of 2024 and wished them a Happy New Year. Also, the Chairman was congratulated on celebrating his 70th birthday and on becoming a grandfather.

The Full Council – 13 December 2023 - motion (AR) and second (MW) that the minutes be approved and signed as correct but note to that Councilor Mr John Griffiths is present at the meeting.

2501

Matters Arising.

2501.1

Llansadwrn Christmas Tree - the Clerk noted that inquiries are in hand to examine the possibility of connecting and supplying electricity close to the play area so that a Christmas Tree can be erected at the end of 2024 and that he would report back to the Council when he had been given more information.

2501.2 Travellers - the Clerk stated that he would report back when he had received more information from the County Council.

2501.3 Lôn Brynteg Footpath - the Clerk had received information from the IACC Footpaths Officer with regards as to who is responsible for maintaining this path. Following information provided, it was agreed that the matter be passed on to the Footpaths Committee for further discussion in March 2024.

2501.4 Highway Matters:

A Allt Cichle (Ty Gwyn site) - following further concerns due to the cold weather, County Councillor Mr Alun Roberts had contacted the IACC Head of Enforcement due to reports that more water was coming from the Building site.

B Following the decision of the December 2023 meeting and with so many Highways issues needing to be resolved, the Clerk confirmed that this will be a special item at the March 2024 meeting and that he will extend an invitation to the Head of Highways Department IACMC and the Local Highways Inspector.

2501.5 Proposed Application (PAC) – Gwel y Llan.
The Clerk reminded that an Open Public Meeting has been arranged for Wednesday, January 17th 2024 in the Parish Hall starting at 7:30pm with the relevant stakeholders to be present in order to receive further questions and listen to local opinion before accepting the Full Planning Application.

2501.6 Arriva Bus Timetable - County Councillor Mr Alun Roberts informed the Community Councillors that an IOACC Emergency Meeting has been convened for Friday, January 12th to discuss the changes to the bus timetable which is having a huge impact on ALL Ward residents Seiriol

2501.7 Seiriol Alliance - Councillor Mr John Griffiths stated that he would be prepared to attend the Annual General Meeting of the Alliance on behalf of the Community Council which is being held on Thursday, 11th January 2024 between 6:00pm & 8:00pm in Llangoed Village Hall.

2502 New Planning Applications.

2502.1 Full application for the erection of a domestic wind turbine 15m high on land near: **Nant y Wennol, Lon Ganol, Llandegfan - FPL/2023/240** - it was noted that the Community Council was strongly opposed to the development and submitted the following comments:

- 1. That comments made by neighbours who live close to the development are fully supportive was factually incorrect as they have written to the Community Council to express their concerns and dissatisfaction with the application.**
- 2. The proposed development is located in a very sensitive area on the edge of an AONB, close to at least 2 popular local footpaths, and overall, it is considered unsuitable for erecting a 15m wind turbine close to a single track country back road that is also unsuitable for larger vehicles.**
- 3. The scale and height of the development will have a detrimental environmental and visual impact on the landscape and local facilities and the surrounding countryside.**
