- 2473 Apologies for absence were received from:** Councillors Miss Joan Kirkham, Mr John Griffiths, Mr Wil Roberts & Mr Michael Willis.
- 2474 Declaration of Personal and/or Prejudicial Interests.**  
**No declaration of personal interest was received which was and/or prejudicial.**
- 2475 Welcome.**  
The Chairman welcomed all the Councillors to the meeting and it was nice to see Councillor Mr John Griffith back among us.
- 2476 To Correct, Approve & Sign Previous Minutes of Meetings.**
- 2476.1 Full Council - 11th October 2023 - motion (GG) and second (EGD) that the minutes and be approved and signed as correct.**
- 2476.2 Footpaths Committee Meeting – 9th October 2023 - motion (SG) and second (TC) that the minutes and be approved and signed as correct.**
- 2476.3 Parish Hall Management Committee Meeting – 13th September 2023 - motion (AR) and second (GG) that the minutes and be approved and signed as correct.**

**2477 Matters Arising.**

**2477.1 Remembrance Sunday Service** - it was noted that all the arrangements on Sunday Afternoon, 12th November 2023 in the Parish Hall starting at 3:00pm are in hand. **Members agreed to make a donation of £100 (s137) to the Royal British Legion**

**2477.2 Christmas Events** - the following were confirmed:

- (i) to receive the Christmas Tree on Tuesday – 28.11.2023.
- (ii) install the lighting on the Tree on Wednesday – 29.11.2023.
- (iii) formally switch on the Tree Lights and culminate this with an event in the Parish Hall on Friday 1.12.2023 including the presence of the Beaumaris Band & Santa Claus.
- (iv) Clerk & Councillor Mrs Nia Foulkes were both thanked for making all the arrangements.

**2477.3 Lon Brynteg Footpath** - following discussion and due to concerns, proposed (NF) and seconded (AR) that the Community Council should take responsibility and cut a section of the path near 'The Stables'. Also, for the Clerk to make inquiries with the IOACC Footpaths Officer in order to find out who exactly is responsible for its maintenance.

**2477.4 Biodiversity Plan** - confirmation from Councillor Mr Michael Willis that he has started drawing up the Plan on behalf of the Community Council and mentioned that Community Engagement will have to be considered in its content. The Chairman thanked him for undertaking this Work.

**2477.5 Llandegfan Parish Hall Matters** - the Clerk confirmed that he had no matters to add from the minutes but said that 'Slimming World' had hired the Hall every Monday for a whole year and that the Youth Club would now have to arrange a different day once they had made a decision to restart.

**2477.6 Highway Matters.**

**2477.6.1 Allt Cichle** - confirmation once again that resurfacing work is in hand but that recent diversion signs have been ignored.

**2477.6.2 Lon Ganol to the Penparc Junction** - serious concerns were expressed about the general condition of the road and that the grass verges had been destroyed by the buses and the tall and heavy vehicles. The passing places and several other places have sunk which are now causing a safety hazard for the smaller vehicles. The surface of the road and the flow of water on either side of Cae Crin is also a serious concern and needs urgent attention.

**2477.6.3 Allt Bryn Mel** - the Clerk reported that he had received correspondence requesting attention be given to maintenance work on overhanging trees along Allt Bryn Mel.

**2477.6.4 Maes Awel Speed Limit Sign** - reports were received that someone had been tampering with the road sign.

**2477.6.5 Lon Plas** - a report was received that patching to the surface and culvert maintenance works are needed.

**2477.6.6 Lon Fferam Lane** - it was reported that a good part of this road needs to be resurfaced.

**2477.6.7 Llansadwrn Flashing Speed Sign** - a report was received that the sign needs attention and modification.

**2477.6.8 New 20mph Speed Limits** - reminded that the Enforcement period is now in force to issue fines for speeding within the limits.

**2477.6.9 Arriva Bus Service** - Councillor Mr Alun Roberts gave a quick update on a recent incident and other issues that the Company was using as an excuse to implement the reduction in services to rural areas.

**2478 Members' Allowance.**

**2480 New Planning Applications.**

**2480.1** Full application for the modification and extension of the existing dwelling and outbuilding together with the erection of a new outbuilding and related works at: **Borthwen, Glyn Garth, HHP/2023/210 – no objection in principle but note that consideration must be given that the site is located in an Area of Outstanding Natural Beauty and any damage it may cause to the Environment around the development.**

**2480.2** Full application for the demolition of an existing boarding house together with the erection of a new boarding house, new access and related works at: **Glan Y Menai, Glyngarth, FPL/2023/88 - members gave the Clerk the Powers to act on behalf of the Council and provide a response to the Planning Department asking the Officer(s) to consider the following Planning policy issues when considering whether the application should be granted or refused.**

- (i) The demolition of the existing property and the proposed location of the new house along the Menai and in an AONB and the visual and environmental impact it will have on the landscape, wildlife and fauna.**
- (ii) Consider and refer to Policy PS17 - Section 6.4.34 (Cluster Area) within the current Joint LDP.**
- (iii) Consider whether the application is contrary to Planning Policies TAI4 and TAI6.**
