- 2511 Apologies for absence were received from:**  
Councillors Mr John Griffiths & Mr Alun Roberts.
- 2512 Declaration of Personal and/or Prejudicial Interests.**  
A declaration of personal interest that was prejudicial was received from Councillor Mr Eurfryn Davies (Item 11.2 - List of Donations) when a donation for the Llandegfan Eisteddfod was discussed as he was a member on the Eisteddfod’s Committee. He left the room and did not take part in any discussion/decision.
- 2513 Welcome.**  
The Chairman welcomed all Councillors to the meeting.
- 2514 Correction, Approval & Signing of Minutes**  
**2514.1** Full Council Meeting - 10 January 2024 - motion (MW) and second (NF) that the minutes are approved and signed as correct.
- 2515 Matters Arising.**  
**2515.1 All Highway Matters:**  
There was once again a general discussion about the state of country lanes around Llandegfan & Llansadwrn and the Clerk confirmed that this would be a special item at the March 2024 meeting and that he will have extended an invitation to the Head of IOACC Highways Department and his Local Highways Inspector.

**2515.2 Proposed Application (PAC) – Gwel y Llan.**  
Both the Clerk and County Councillor provided a feedback report following the Open Public Meeting held on Wednesday, 17th January 2024 and outlined the many concerns expressed by members of the public, primarily, the proposed new access and the local and social need for such a development. Following a lengthy general discussion, the Community Council would now wait for the receipt of the Full Planning Application.

**2515.3 Arriva Bus Timetable -** County Councillor Mr Carwyn Jones provided the latest update on the ongoing issues surrounding the Arriva Bus Service and the latest exploration in creating a Community Transport Bus Service in partnership with the Seiriol Alliance Good Turn Scheme.

**2516 Cylch Cyttir Signage.**  
Recommendations were discussed for placing signs and an information board in the nature reserve indicating the footpaths and to ask Councillors to suggest and choose their preferred option.

**2517 New Planning Applications.**  
Additional Information - Full application for the erection of a domestic wind turbine 15m high on land near: **Nant y Wennol, Lon Ganol, Llandegfan - FPL/2023/240** – it was noted that the Community Council remains strongly opposed to the development and that the applicant had not shown and submitted sufficient evidence to the previous concerns and comments that had been raised. There was also a strong feeling that approving this plan close to neighbouring properties may lead to and set a dangerous precedent.

**2518 Planning Applications Decisions: none received.**

**2519 County Councillor's Report**  
County Councillor Mr Carwyn Jones gave a verbal report regarding the resurfacing of Lon Fferam Uchaf, Llansadwrn within the next two weeks, fly tipping on the B5109, parking issues in Bro Llywelyn, a gritting application for the Old Village, horses using the Lôn Fain footpath, defective and faulty Scottish Power lighting and cabling works along Gwel Eryri and an explanation as to why green bins are not included as part of every resident's Council Tax.
