- 2525 Apologies for absence were received from:**

- 2526 Declaration of Personal and/or Prejudicial Interests.**  
There was no declaration of personal interest that was prejudicial before and during the meeting.
- 2527 Welcome.**  
The Chairman welcomed all Councilors to the meeting and to Mrs Delyth Ingram (Menter Mon) for item 4 on the program (Pathways Matters).
- 2528 Correction, Approval & Signing of Minutes**
- 2528.1 Full Council Meeting – 14 February 2024.**  
**Motion (JWG) and second (MW) that the minutes be approved and signed as correct.**
- 2529 Footpaths Matters.**  
There was a discussion and decision on the design of signs indicating 'Cylch Cyttir' and Delyth informed the Council that the leaflets have not yet been printed. The Council was also told that the landowners of Tan y Graig & Cyttir Bach that form part of the 'Cylch Cyttir' network, whose land has been impassable for most of the year due to drainage have agreed and given permission for any

remedial work to be done that will be paid by Cwlwm Seiriol. There will also be Heathland clearance on the Common land by volunteers who will also install Bird & Bat boxes. There was the suggestion that the Seiriol Alliance employs a new part-time officer once the Cwlwm Seiriol project comes to an end later in the year. Delyth was thanked for her attendance and that the Council should look to revisit the issue in July.

**2530 Highways Matters.**

A number of Highways matters were reported and discussed, including:

- 2530.1 Note that the road between Llandegfan Church and Pentraeth Automotive needs resurfacing works.
- 2530.2 The Clerk's report that he has applied through Anglesey County Council to rename this road 'Lôn Pedair Groeslon'.
- 2530.3 A further request was made to address the surface and flooding at Cae Crin.
- 2530.4 It was also reported that the work of repainting the white lines near the School had been done.
- 2530.5 The local authority was thanked for starting the flood alleviation work along Lôn Ganol.
- 2530.6 Problems continue with roadside parking by contractors at the bottom of Allt Cichle.
- 2530.7 Finally, it was said that cable work along Mill Lodge had been completed.
- 2530.8 Temporary Through Traffic Order – Lon Treffos, Llansadwrn – on the 14th of March to allow safe access for the installation of new poles.

**2531 New Planning Applications.**

**2531.1** Amended plans - Full application for a change of land use to accommodate 55 fixed caravans/holiday cabins, change the use of the external building to a laundry, reception and office together with the construction of new roads on the site, lift sewage treatment building, construction of a car park, soft and hard landscaping works and related works at **Wern Farm, Pentraeth Road, Menai Bridge - FPL/2023/118**

**Following discussion, it was decided that the Community Council should reject the application because the size of the development, that there was no need for additional permanent caravans/holiday cabins in the area and the sacrifice of and the sacrifice of prime agricultural land in order the create the development far away from local amenities and that there was no easy footpath access to nearby shops along the busy A5025 contrary to the relevant planning policy. Concerns were also expressed that noise and light pollution from such a development would be harmful to the local wildlife and habitat close to an AONB & SSI.**

**2532.1** Full application for the demolition of the existing cantilevered parking area , stabilization work for the entire bank, building a new garage/annex and a new parking space at: **Min y Garth, Ffordd Beaumaris, Porthaethwy – HHP/2022/294 – WITHDRAWN.**
