- 2789.1 Croesawyd Mr Peter Williams & Mr Michael Stops (Grwp Natur Seiriol) i'r cyfarfod.
- 2789.2 Cafwyd cadarnhad ganddynt fod eu cais drwy Cronfa Loteri Arian I Bawb wedi bod yn llwyddiannus (odditeu £20,000).

To Accept any apologies:

An apology was received from: Cllr Mr William Roberts.

2785

Welcome from the Chairman.

All the Councillors present were welcomed to the first meeting of the new year by the Chairman. They were thanked for making the effort to attend the emergency meeting and he explained the reasons for doing so.

2786

Declaration of any Personal/Prejudicial Interest

No personal and/or prejudicial interest was declared before and/or during the meeting.

2787

Community Garden & Trees surrounding the Hall.

The Clerk had already shared the North Wales Fencing Company's report and quotation (£10,467 + VAT). Following a long and concise discussion, it was proposed and seconded (JG/NWF) to install a new (replacement) palisade fence in accordance with the quotation and make a contribution of up to £150.00 to the residents of Cae'r Ffynnon for the damage on their side of the boundary.

2788

Parish Hall Matters.

There was a discussion on the following.

2788.1

It was unanimously agreed to a payment of £1,200 (JG/JWG) to Cllr Mrs Nia Foulkes for the time spent cleaning the Hall over the last 3 years. Cllr Foulkes was requested to leave the room while the matter was being discussed and agreed.

- 2788.2 Agree to review the hiring fees of the Hall in March 2025.
- 2788.3 It was noted that the external lights were not working - Clerk to contact GD Electrical and ask them to carry out any necessary repair work and to also look at the extraction fan in the men's toilets.

2789 Footpath Matters.

- 2789.1 Mr Peter Williams & Mr Michael Stops (Seiriol Nature Group) were welcomed to the meeting.
- 2789.2 Confirmation that their application through the Awards for All Lottery Fund had been successful (about £20,000).
- 2789.3 They had also prepared a map of the paths to be included in their planned work for the next 12 months for the Cwm Cadnant area (Cylch Cyttir) in order to improve the network of paths and this included the Cyttir Nature Reserve. Following a long and concise discussion, it was agreed to work in partnership with the Group and to organize a further meeting before Easter.
- 2789.4 Noted a County Council Order to Close Part of Public Path No. 13 and create another path in its place following the approval of the new development on land at Gwel y Llan.

2790 Highway Matters.

The following were noted:

- 2790.1 Water problems that needed attention had surfaced once again near Cae Crin and the condition of the surface and layby along Mile Lane was again giving cause for concern - County Councilor, Mr Alun Roberts to contact the County Council's Highways Inspector.
- 2790.2 There was a report on the large tree that fell near Bryngwyn, Hen Landegfan following Storm Darragh which caused the road to Beaumaris to be temporarily closed.
- 2790.3 There was a report that repair work to the damage on Old Cadnant Bridge on Lôn Pedair Groeslon had been completed.

2790.4 A report was received that the County Council's Enforcement Officer had been contacted to conduct a site visit to the land near Erw Hywel Terrace following local environmental concerns.

2790.5 Noted that the A545 will be temporarily closed on the 1st & 2nd of March 2025 due to the Ynys Môn Half Marathon & 10KM.

The Chairman again thanked the Councillors for their attendance and the meeting ended at 1:20pm.
