- 2793 Accept any apologies:**  
**An apology was received from:** Cllr Mr William Emrys Roberts.  
**Also:** County Cllr Mr Gary Pritchard.
- 2794 Welcome from the Chairman.**  
A warm welcome was given to all Councillors present by the Chairman.
- 2795 Declaration of any Personal/Prejudiced Interest**  
Cllrs Mr Eurfryn Davies and Mr Alun Roberts both declared a personal interest that was prejudicial when it came to discussing donations to the Llandegfan Eisteddfod and Eisteddfod Môn Bro Seiriol (see minute 2809) as they were both members of their respective Committees.
- 2796 To Receive, Approve & Sign Minutes of Previous Meetings.**
- 2796.1** Full Council Meeting – 13.11.2024 - **proposed (JG) & seconded (NF) to accept and sign that the minutes are correct.**
- 2796.2** Full Council Meeting – 18.12.2024 - **motion (AR) and second (SG) to accept and sign that the minutes are correct.**
- 2796.3** Full Council Meeting – 17.1.2025 - **motion (MW) and second (NF) to accept and sign that the minutes are correct.**

**2797 Playground Inspection Report & Grass Cutting Contract.**

The following issues were discussed and agreed:

**2797.1 Completion of the 2024 Playground Inspection Visit -** confirmation from the Clerk that he has acknowledge the quote received from Cwmni GL Jones of Bethesda (£7,000 + VAT) for the Multi-Use Play Equipment in Llansadwrn and has included it in the precept expenditure for 2025/2026. It is expected that the work will be completed before Easter 2025.

**2797.2 Grass Cutting Tender -** confirmation by the Clerk that he has received TWO tender prices for cutting the grass in BOTH playgrounds. **After a brief discussion, it was proposed (MW) and seconded (NF) to accept Mr Tristan Oldham's price of £125 x 12 for each playing field (£3,000 in total) and ask the Clerk to include it in the precept expenditure for 2025/2026 and send him an appropriate agreement as soon as possible.**

**2798 Dog Dispenser & Supplier of Dog Bags 2025/26.**

There was a discussion and decision on the following issues:

**2798.1** Confirmation by the Clerk that the pole for the additional dispenser that was purchased and to be located in the layby opposite Rysgol Farm will be installed as soon as possible.

**2798.2 Proposed (NF) & Seconded (EGD) to order 25 boxes of dog dispenser bags for 2025/2026 and due to concern of misuse, to review the situation in 12 months and put a note on the local Community Facebook.**

**2799 Highways Matters**

The following issues were discussed:

**2799.1 Lôn Allt Bryn Mel -** uncertainty remains as to whether there was any development – agreed that County Councillor Mr Alun Roberts would follow up the Council's concerns with the County Council's Highways Department regarding the request to cut back the branches and hedges that have overgrown and are blocking the highway and whether the landowners had been instructed to cut back the overgrowth on their own private land.

**2799.2 Consultation on the 20mph Speed Limits** - the Clerk said that he had not heard from the County Council's Highways Department whether the Community Council's request to move the 20mph speed limit sign at the bottom of Allt Cichle closer to the village before reaching Bron Haul Estate had been discussed. **Motion (JG) and second (NF) that the Community Council should challenge any decision to reject the application.**

**2799.3 Cae Crin, Hen Bentref** - a report from Cllr Mr Alun Roberts was noted and that Mr Sion Owen from the County Council's Highways Department had been appointed to look into the problems and concerns of water collecting near the property and the condition of the road surface and layby along Lon Filltir.

**2799.4 Erw Hywel Terrace** - confirmation that the Community Council expects a site visit report from the County Council's Enforcement Officer following the raising of local environmental concerns.

**2799.5 Potholes** - there was a report and discussion of several potholes that have appeared at various places around the village and that attention was needed to the surface of the roads which were in poor condition.

**2800 Footpath Matters.**

**2800.1 Footpath Review 2024** - following a full review of the paths and the document provided, the Clerk requested a special meeting to discuss the list and the paths 2025 maintenance contract agreement in March (AGREED). In the meantime, it was requested that the Clerk contact Mr Arwel Evans, the County Council's Footpaths Officer regarding boardwalk concerns on several paths and ask for any guidance/assistance.

**2801 Community Council Biodiversity Plan.**

A request was made for the document to appear on the Community Council's website and that the document be translated into Welsh. The Clerk will undertake this work as soon as possible.

**2802 Members' Allowances.**

It was noted that all Councillors had completed the form to opt out from receiving their compulsory option to accept their allowance of £156.00 in accordance with the approval of the IPRM.

**2803 Parish Hall Matters.**

**2803.1** A copy and note of the Hall Accounts (certified) was distributed up to 31.3.2024 with a full list of 2023/24 hiring income for the Hall.

**2803.2** Confirmation that external lighting has received attention / repair and that 'PAT testing' of each apparatus has been completed.

**2803.3** Confirmation by the Clerk that he needs to re-engage with Matthew Parry Roofing Contractors for the roof repairs needed above the Porch/Hall's main entrance.

**2804 Community Garden & Trees Around the Hall.**

**2804.1** Following the previous discussion and decision, it was noted that the Council had suspended its Financial Regulations in installing the new fence (£10,467 + VAT) on the condition that it was an urgent matter and that only ONE quotation was accepted because North Wales Fencing Company were the Contractors who had previously installed the Fence around the Play Area in Llandegfan. A full risk assessment had been considered and this was drawn up and presented in advance to all Council members. The Clerk now confirmed that he had ordered the work to be completed as soon as possible.

**2804.2** Following concerns, confirmation from the Clerk that he has contacted Underhill & Son to provide an inspection, report and quotation of the fragile trees around the Hall that needed urgent attention and will come back to the Councillors once this has been done.

**2805 Oliver Family Memorial Plaque.**

There was a request that the plaque be placed in the appropriate place as soon as possible. Clerk agreed to make the arrangements.

**2806 Community School Defibrillator.**  
The Clerk said that he will arrange to transfer responsibility for the machine with the Head of School as soon as possible.

**2807 Report of the County Councillor.**  
A brief report was given by County Councillor Mr Alun Roberts on the problems caused following the cancellation of Bin Collections and School Closures together with the tree that fell on the A545 near Glyn Garth following Storm Eowyn. He also mentioned the County Council's upcoming Education +16 consultation on the Island and that a new Modular Childcare Unit had arrived and installed in the Seiriol Area (Ysgol Gynradd Llangoed).

**Community Council Precept 2025 / 2026.**
